

Waiver of Liability Relating to Coronavirus/COVID-19

ASSUMPTION OF RISK: I have read and fully understood the above warning concerning COVID-19.

This event of such value to me [and/or to my children,] that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to attend PNA's 58th National Golf Tournament.

WAIVER OF LAWSUIT/LIABILITY: I _____ hereby forever release and waive my right to bring suit against PNA and Lodge 664 and its owners, officers, directors, managers, officials, trustees, agents, employees, or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to attending PNA's 58th National Golf Tournament. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

CHOICE OF LAW: I understand and agree that the law of the State of Illinois will apply to this contract.
